EN 2022 SPECIFICATION

Safety footwear is classified in the UK and EU by the EN 20345 standard using a categorisation of S1 through to S7 to quickly determine the level of incorporated safety components. This is further supported by letter codes for additional safety components or tests the footwear has undercone.

S3L, S5L, S7L specifiy non-metal midsole tested at 1100N with a 4.5mm nail.

S3S, S55, S75 specify non-metal midsole tested at 1100N with a 3mm nail.
